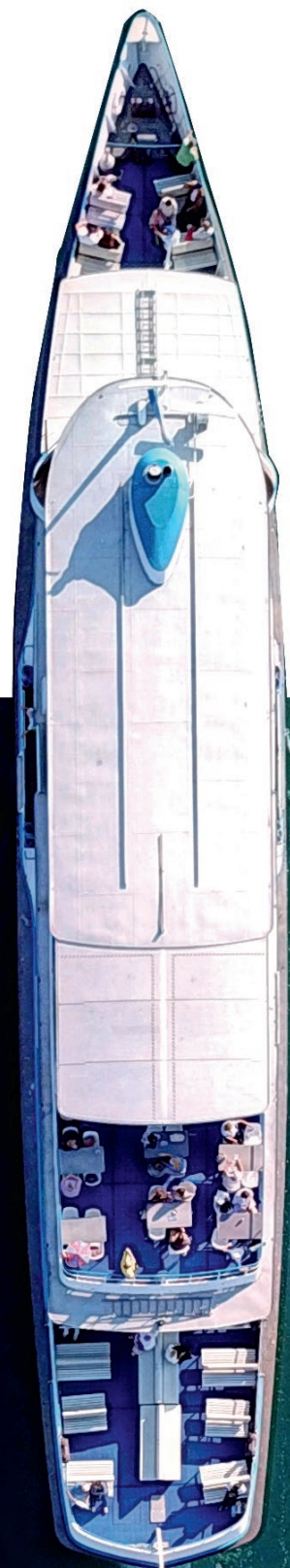
# ARNECKE SIBETH DABELSTEIN SHIPPING LAW AND MARINE INSURANCE SCHOLARSHIP 2023

The participants shall also enjoy what Hamburg has on offer in political, historical and entertainment terms. Each young colleague will have free accommodation and free public transportation within Hamburg. The programme's language is English. The five scholars will come from different countries, endorsing the international character of the scholarship to promote international understanding and co-operations between young fellow colleagues working in similar areas of the law. Previous scholars came inter alia from Turkey, India, Denmark, Egypt, England, Italy, Netherlands, Mexico, Sweden, Norway, Russia, Nigeria, Japan, New Zealand, Finland, Ukraine and the United States.
